## Introduction


In exercise of the powers conferred by section 24O of the Civil Aviation Act 1969 [Act 3], the Chief Executive Officer makes this Civil Aviation Directive (CAD) 7301 – Aircraft Mortgage, pursuant to Regulation 17, 18, and 19 of the Malaysian Civil Aviation Regulations (MCA 2016).

This CAD contains the standards and requirements pertaining to aircraft mortgage and is compliant with Malaysian Civil Aviation Regulations.

This Civil Aviation Directive 7301 – Aircraft Mortgage is published by the Chief Executive Officer under Section 24O of the Civil Aviation Act 1969 [Act 3] and come into operation on 1<sup>st</sup> April 2021.

### Non-compliance with this CAD

Any person who contravenes any provision in this CAD commits an offence and shall on conviction be liable to the punishments under Section 24O (2) of the Civil Aviation Act 1969 [Act 3] and/or under Malaysia Civil Aviation Regulation 2016.

## 1 General and Definition

### 1.1 Citation

1.1.1 These Directives are the Civil Aviation Directive 7301 – Aircraft Mortgage, Issue 01/Revision 00, and comes into operations on 1<sup>st</sup> April 2021.

1.1.2 This CAD 7301 – Aircraft Mortgage, Issue 01/Revision 00 will remain current until withdrawn or superseded.

### 1.2 Applicability

1.2.1 This CAD shall apply to a person who intended to enter a mortgage of an aircraft in the Aircraft Register.

### 1.3 Revocation

1.3.1 This CAD revokes Notice 7301 issue 1 dated 15<sup>th</sup> April 2016.

### 1.4 Definition

1.4.1 In this CAD, unless the context otherwise requires:

**Aircraft Register** means the Aircraft Register kept and maintained by CAAM under regulation 10 of the Civil Aviation Regulation 2016;

**CAAM** means Civil Aviation Authority of Malaysia; and

**MCAR** means Civil Aviation Regulations 2016.

## **2 Entry of Aircraft Mortgage**

- 2.1 Any mortgage of a Malaysian aircraft may be entered in the Aircraft Register.
- 2.2 Application to enter a mortgage in the Aircraft Register shall be made to CAAM.
- 2.3 An applicant for the entry of aircraft mortgage shall -
  - a) submit an application form CAAM/AW/7301-01 in duplicate;
  - b) accompanied by the applicable fee; and
  - c) submit a certified true copy of the mortgage.
- 2.4 For the purpose of 2.3(c) of this CAD, where the mortgage is in a language other than the national language or English, the application shall also be accompanied by a certified true copy of mortgage and translation of the mortgage in the national language or English language.
- 2.5 Where two or more aircrafts are the subject of one mortgage or where the one aircraft is the subject of two or more mortgages, separate applications shall be made in respect of each aircraft or of each mortgage.

### **3 Amendment of Mortgage Particulars In Aircraft Register**

- 3.1 Application to amend the particulars of aircraft mortgage in the Aircraft Register shall be made to CAAM.
- 3.2 An applicant shall -
- a) submit an application form CAAM/AW/7301-02 in duplicate;
  - b) submit a documentary evidence to amend particulars of aircraft mortgage;  
and
  - c) accompanied by the applicable fee.
- 3.3 Notwithstanding 3.2 of this CAD, the applicant shall submit any document as may be required by CAAM

## **4 Removal of Entry Of Mortgage From Aircraft Register**

- 4.1 Application to remove any entry of mortgage in the Aircraft Register shall be made to CAAM.
- 4.2 An applicant shall -
- a) submit an application form CAAM/AW/7301-03 in duplicate;
  - b) submit a documentary evidence such as a document of discharge or a receipt for the mortgage money; and
  - c) accompanied by the applicable fee.
- 4.3 Notwithstanding 4.2 of this CAD, the applicant shall submit any document as may be required by CAAM.
