 - e) Key plan, location plan and building and/or crane plan in size A3 (if applicable);
 - f) For crane application, the applicant must provide coordinates for each crane, the number of cranes, and the operating time and date (starts and ends) (if applicable);
 - g) Deed/Land title information (if applicable); and
 - h) Consent letter from airport operator for application within the perimeter of an aerodrome (if applicable).
2. The fee for each application is RM1,000. (Ringgit Malaysia One Thousand Only). Amendments to the content of the approval letter are also considered as new applications.
