### **EXTENSION TO THE TRANSITION PERIOD FOR CAAM ECLIPSE CARD-TYPE LICENCE**

## **1 Introduction**

- 1.1 This Advisory Information (AI) is issued to notify all Civil Aviation Authority of Malaysia (CAAM) licence holders (Flight Crew Licence, Aircraft Maintenance Licence, Air Traffic Control Licence) of the extension to the transition period for the implementation of the card-type licence format. This update supersedes the timelines previously communicated in AI 03/2025, dated 11 April 2025 and AI 06/2025, dated 19 June 2025.
- 1.2 The extension provides CAAM licence holders with additional time to complete the transition from the existing book-format licence to the new card-type licence, which has been digitised under the eCLIPSE system administered by CAAM.
- 1.3 CAAM will continue to issue and distribute the card-type licences that have been approved and printed.

## **2 Extension of Transition Period**

- 2.1 CAAM acknowledges the necessity of extending the transition period to facilitate the issuance of card-type licences. Throughout this period, both card-type licences and the existing book-format licences shall remain valid and acceptable for all regulatory and operational purposes.
- 2.2 The transition period will conclude on **31 December 2025 at 2400LT**. Effective **1 January 2026 at 0001LT**, book-format licences will no longer be recognised, except in genuine circumstances such as for validation purposes. Thereafter, all CAAM licence holders must hold and present a valid card-type licence, together with a valid medical certificate (where applicable), in order to be deemed compliant.

## **3 Responsibilities of Licence Holders**

- 3.1 CAAM wishes to highlight the critical importance of timely participation by licence holders in the transition to the eCLIPSE system. All CAAM licence holders are strongly advised to regularly monitor their eCLIPSE portal and promptly respond to any required actions from CAAM to ensure compliance.

- 3.2 Licence holders are responsible for ensuring that their personal and professional information within the eCLIPSE system remains accurate and up to date. Upon receipt of the new card-type licence, licence holders should promptly notify their current employer or organisation.
