MFA TRAINING FLIGHT SKIDDED OFF THE RUNWAY AT MALACCA AIRPORT

PUTRAJAYA - The Civil Aviation Authority of Malaysia (CAAM) confirms an incident involving a Piper PA-28-181 aircraft, registration number 9M-SKR on a training flight at Malacca Airport on Thursday, 7 August 2025 at 2.55 p.m. The aircraft, operated by Malaysian Flying Academy Sdn. Bhd. (MFA), had landed and skidded off the runway upon touchdown.

There was one pilot on board and is currently receiving medical treatment. The aircraft removal and a full runway inspection have been carried out to ensure safe operations of the airport. The safety investigation will be conducted by the Air Accident Investigation Bureau under the Ministry of Transport Malaysia in accordance with Part XXVI Civil Aviation Regulations 2016.

PESAWAT LATIHAN MFA TERSASAR DARI LANDASAN DI LAPANGAN TERBANG MELAKA

PUTRAJAYA – Pihak Berkuasa Penerbangan Awam Malaysia (CAAM) mengesahkan satu insiden melibatkan sebuah pesawat jenis Piper PA-28-181 dengan nombor pendaftaran 9M-SKR dalam penerbangan latihan di Lapangan Terbang Melaka pada hari Khamis, 7 Ogos 2025, jam 2.55 petang. Pesawat yang dikendalikan oleh Malaysian Flying Academy Sdn. Bhd. (MFA) itu telah mendarat dan tersasar keluar dari landasan.

Insiden melibatkan seorang juruterbang dan beliau kini sedang menerima rawatan perubatan. Proses pengalihan pesawat dan pemeriksaan penuh ke atas landasan telah dilaksanakan bagi memastikan keselamatan operasi lapangan terbang. Siasatan lanjut akan dijalankan oleh Biro Siasatan Kemalangan Udara di bawah Kementerian Pengangkutan Malaysia selaras dengan Peraturan XXVI, Peraturan-Peraturan Penerbangan Awam 2016.
