AKTA PENERBANGAN AWAM 1969

PERATURAN-PERATURAN PENERBANGAN AWAM (PENGECUALIAN) (NO. 3) 2018

PADA menjalankan kuasa yang diberikan oleh perenggan 3(2)(p) Akta Penerbangan Awam 1969 [*Akta 3*], Menteri membuat peraturan-peraturan yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Penerbangan Awam (Pengecualian) (No. 3) 2018**.

(2) Peraturan-Peraturan ini mula berkuat kuasa pada 1 Mei 2018.

Pengecualian

2. (1) Anggota kru penerbangan Malindo Airways Sdn. Bhd. dikecualikan daripada sekatan berhubung dengan masa penerbangan di bawah subperenggan 74(a)(ii) Peraturan-Peraturan Penerbangan Awam 2016 [*P.U. (A) 97/2016*].

(2) Pengecualian di bawah subperaturan (1) tertakluk kepada syarat bahawa pada permulaan penerbangan anggota kru penerbangan itu, agregat bagi semua masa penerbangannya yang sebelum itu semasa tempoh dua belas bulan yang berakhir pada akhir bulan sebelumnya hendaklah tidak melebihi seribu jam.

CIVIL AVIATION ACT 1969

CIVIL AVIATION (EXEMPTION) (NO. 3) REGULATIONS 2018

IN exercise of the powers conferred by paragraph 3(2)(p) of the Civil Aviation Act 1969 [*Act 3*], the Minister makes the following regulations:

Citation and commencement

1. (1) These regulations may be cited as the **Civil Aviation (Exemption) (No. 3) Regulations 2018**.

(2) These Regulations come into operation on 1 May 2018.

Exemption

2. (1) A member of a flight crew of Malindo Airways Sdn. Bhd. is exempted from the restriction in relation to flight times under subparagraph 74(a)(ii) of the Civil Aviation Regulations 2016 [*P.U. (A) 97/2016*].

(2) The exemption under subregulation (1) is subject to the condition that at the beginning of the flight of the member of the flight crew, the aggregate of all his previous flight times during the period of twelve months expiring at the end of the previous month shall not exceed one thousand hours.
