FEES AND CHARGES FOR CONSULTATIONS ON OBSTACLE CONTROL LIMITATIONS

1 Introduction

- 1.1 This Advisory Information (AI) is to notify the aviation industry, specifically to contractors, consultants, developers, and owners of building or structure regarding the charging of fees on consultation for Obstacle Control Limitations (OCL) in accordance with item 124 as specified in the Schedule of the Civil Aviation (Fees and Charges) Regulations 2016.

2 Consultation with CAAM Air Navigation Services and Aerodrome Division (ANSA) Personnel

- 2.1 Any consultation with the ANSA personnel seeking for advice or aeronautical information relating to application of OCL shall be charged in accordance with item 124 as specified in the Schedule of Civil Aviation (Fees and Charges) Regulations 2016.
- 2.2 The consultation packages may be selected from the tables below:

Consultation Fee: RM300/per person/per hour

Note. – The minimum chargeable consultation session is 1 hour, and any additional hours will be charged RM300 per person. For those charges, “per person” is referred to the number of ANSA personnel providing consultation.
