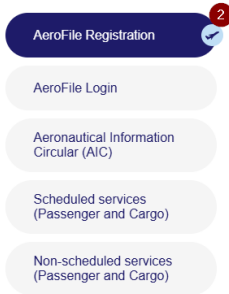
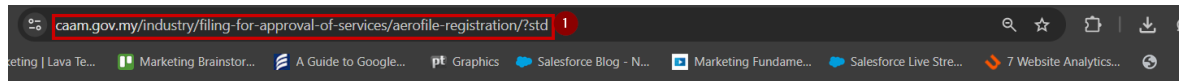


Registration Process

Registration

Effective 1st August 2018, all airlines intending to overfly Malaysia's airspace as well as operate scheduled and non-scheduled commercial flights to/from Malaysia, are required to obtain overflight/landing permits via the AeroFile portal. Please note that the portal does not cater for the application for slots and airlines are required to apply for slots with the National Slot Coordination Malaysia ("NSCM").

AeroFile acts as a single-entry point by integrating the Civil Aviation Authority of Malaysia ("CAAM") and NSCM, the agencies responsible for overflight and landing permit applications. This portal aims to facilitate airlines' operations to/from Malaysia by providing a one-stop web-based application system that will reduce the need for paperwork and processing periods.

Supporting Documents Required

- **For Malaysian AOC holders wishing to file for landing permits:**

1. Copy of valid Air Operator Certificate (AOC);
2. Copy of Air Service Licence / Permit ("ASL" / "ASP");
3. Copy of Certificate of Registration (CoR);
4. Copy of Certificate of Airworthiness (CoA); and
5. Copy of Insurance Coverage;
6. Appointment letter to third party handler / aviation management service provider filing on behalf (if applicable).

- **For foreign AOC holders wishing to file for landing permits:**

1. Copy of valid Air Operator Certificate (AOC);
2. Copy of valid Designation Letter (for scheduled operations); and
3. Copy of the Foreign AOC Validation (refer to: AIC 03/2019);
4. Copy of Insurance Coverage.
5. Appointment letter to third party handler / aviation management service provider filing on behalf (if applicable).

- **For AOC holders wishing to file for overflight ONLY:**

1. Copy of valid Air Operator Certificate (AOC)
2. Appointment letter to third party handler / aviation management service provider filing on behalf (if applicable).

- max of 10MB per attachment

- file extensions formats supported are: .docx, .doc, .pdf, .jpg, .png and .tiff
