Job Description

Responsible for leading, supervising and guiding the work undertaken by other members of the Division, as well as managing regulatory and competition economics matters and supporting the development of the civil aviation industry in Malaysia.

- Provide strategic leadership in managing, reviewing, and supervising analytical and administrative work carried out by the Department.
- Develop and prepare strategy papers, policy documents, and advisory materials for the civil aviation services sector.
- Collect, compile, and analyse economic data to support regulatory and competition cases, as well as broader sector development initiatives.
- Conduct statistical and economic analysis using contemporary quantitative tools on research findings to generate insights that inform recommendations and decision-making.
- Develop market scenarios for the aviation sector, including analyses of pricing, production/services, and usage trends.
- Perform regression analysis, econometric modelling, and demand forecasting to support regulatory and policy objectives.
- Lead and conduct research, studies, and public inquiries related to the aviation services sector and competition/regulatory matters in the relevant markets.
- Review and evaluate aviation sector rules, regulations, and policies, mainly from the economics and economic-policy perspective.
- Undertake market surveillance activities and maintain databases for monitoring market performance and competitiveness.
- Prepare periodic reviews and reports on the progress, trends, and developments within the aviation services markets.
- Collect and compile economic data to provide evidence for regulatory and competition cases, as well as to support sector development initiatives.

Qualifications for Appointment

Candidates must possess the following criteria:

- Malaysian citizen.

b) Academic & Professional Qualifications

- A Masters degree in any of the following subjects: economics, law, public policy from a higher education institution recognized by the Government, or an equivalent qualification.

- At least 10 years of experience in a management or leadership role
