

### **About this Application Form:**

This form is approved by the Civil Aviation Authority of Malaysia (CAAM) for the application for establishment of new aerodrome. The application form is made up of nine (9) sections as follows:

- 1) Section A – Particulars of the Applicant
- 2) Section B – Particulars of Proposed Aerodrome Site
- 3) Section C – Proposed Aerodrome Operations
- 4) Section D – Proposed Physical Infrastructure
- 5) Section E – Proposed Emergency Services
- 6) Section F – Proposed Air Traffic Management
- 7) Section G – Authority Approval
- 8) Section H – Applicants Declaration

### **Guidelines for Completing this Application Form:**

All applicants shall fill all sections of this application form. All information will be used to assess if the applicant is entitled to an authorisation by Minister for establishment of aerodrome. An incomplete, poorly prepared or inaccurate application may:

- Result in rejection of the application
- Result in delays
- Result in a refusal to authorisation for establishment of aerodrome

**Giving false or misleading information is an offence under Regulation 67(1)(c) of the Civil Aviation (Aerodrome Operations) Regulations 2016.**

If the form is filled by hand, use block letters and either a black or blue ballpoint pen. Some questions contain check boxes or columns to be ticked, annotate with a 'X' where appropriate (e.g. columns where there is a YES/NO option). This information is used by the Air Navigation Services and Aerodrome Division when going through the application package.

### **Category of aerodrome may be referred in Malaysia Civil Aviation (Aerodrome Operation) Regulation 2016:**

For the purposes of these Regulations, aerodromes shall be categorised as follows:

- a) Category 1: Government aerodrome available for use by commercial air transport aircraft;
- b) Category 2: Government aerodrome not available for use by commercial air transport aircraft;
- c) Category 3: private aerodrome available for use by commercial air transport aircraft; and
- d) Category 4: private aerodrome not available for use by commercial air transport aircraft.



**Required Documentation Supporting this Application:**

Preliminary Technical Study (PTS) contains but not limited to:

- a) physical characteristics on related infrastructure and facilities and suitability of the site in relation to development, topography and obstacles around the aerodrome site;
- b) impact on other aerodromes or landing sites including military aerodromes, controlled airspace and any airspace restrictions;
- c) the suitability of the type of aircraft and the proposed flight operating procedures for the aerodrome; and
- d) land use, environmental protection issues and other related approvals that may need to be obtained from other Authorities.

*Note. – All documents are to be prepared and made readily available to process this application in electronic format. CAAM may request for hard copies if required.*
