GENERAL INFORMATION

Note - This form shall be used for requests to transport dangerous goods by air that do not comply with the normal requirements of the ICAO Technical Instructions for the Safe Transport of Dangerous Goods by Air (Doc 9284). If there is insufficient space to list all items, they can be listed on a separate sheet.

1. This form is for exemption applications related to the transport of forbidden dangerous goods by air.
2. The form must be typewritten, complete, and bear the original company stamp.
3. All documents listed in the Checklist must be attached, clear, and legible; failure to provide a complete submission will result in processing delays.
4. All applications are subject to a fee of RM 3,000.00 (Civil Aviation Regulations 2016) and must comply with Malaysian laws and ICAO standards.
5. Submission of this form does not constitute approval. The technical evaluation and audit process will require additional time depending on the complexity of the safety demonstration and the applicant's responsiveness to findings.
6. Final approval will be issued within fourteen (14) working days only after CAAM is fully satisfied that equivalent safety has been successfully demonstrated.
