1. This form is for applications related to the approval of Special Provisions for the transport of dangerous goods by air.
2. The form must be typewritten, complete, and bear the original company stamp.
3. All documents listed in the Checklist must be attached, clear, and legible; failure to provide a complete submission will result in processing delays.
4. All applications to transport dangerous goods by air are subject to the laws and regulations of Malaysia and ICAO standards.
5. Submission of this form does not constitute approval. The technical evaluation and audit process will require additional time depending on the complexity of the safety demonstration and the applicant's responsiveness to findings.
6. Final approval will be issued within seven (7) working days only after CAAM is fully satisfied that equivalent safety has been successfully demonstrated.
